5. Refunds will be made within 90 days of termination or receipt of Cancellation Notice.
6. Student records from the academy will remain on file for at least one year.

All prices for programs are as printed herein. Costs of equipment and books are included only when a student has paid in full for entire 12 week course. If a student chooses to pay in weekly, monthly, or by phase, additional costs for equipment, supplies and text books of \$1,000.00 shall apply and are necessary for program completion. If a student chooses to attend a school approved dog show or professional seminar for credit, the student will have to pay the admission fee and arrange their own transportation for that event. Although available, these events are not required for program completion.
